DESCRIPTION OF POSITION:

Under the direction of the Director of Student Support Services to provide remedial programs and instructional activities to students with speech and language disorders.

QUALIFICATIONS:

1. Physically, mentally, emotionally, and morally fit to undertake responsibilities involving the education and welfare of children and accountability for valuable school property. Able to work in a harmonious relationship with all District personnel. Must successfully complete a medical examination and be free of communicable disease.
2. Must hold a California credential authorizing service as a Remedial Speech Specialist, i.e., the Exceptional Child-Speech Hearing Credential, Standard Credential with specialization in the Speech and Hearing Service, Restricted Speech Hearing Credential, Clinical Services, Rehabilitation Credential.
3. Must hold a Baccalaureate Degree with a major or specialized training in speech-language; a Master's Degree in speech pathology or a closely related field is highly desirable.
4. Must have successfully completed a practicum in speech and language, or one year of full-time successful experience as a remedial speech specialist. Applicants who have demonstrated knowledge and experience with programs designed to improve educational opportunities for minority pupils will be given preference.
5. Must have the demonstrated ability to work effectively with professional and paraprofessional personnel in carrying out an effective instructional or remediation program for speech-language pupils.

6. Must possess knowledge of recent educational and remediation trends related to speech-language handicapped.
7. Must have available private transportation.
8. Such alternatives to the above qualifications as the Board of Trustees may find appropriate and acceptable.

DUTIES

1. Assesses the speech-language needs of pupils in order to design and implement appropriate remediation and instructional plans and strategies.
2. Provides remedial speech-language services for regular school and exceptional pupils in the Special Education programs.
3. Provides an educational environment which establishes, maintains, and reinforces appropriate pupil behavior, attitudes, and social skills.
4. Provides a variety of educational and remedial experiences based on an objective oriented format to stimulate an interest in speech and language remediation.
5. Maintains a variety of pupil records, including anecdotal records for each pupil which outlines his speech-language program, objectives, and instructional activities, and the expected result of the individualized educational program.
6. May counsel students, parents, and other professional and paraprofessional personnel regarding the social, emotional, and educational needs of the pupils within the speech and language programs.
