DESCRIPTION OF POSITION:

Under the direction of the Director of Student Support Services, provides special instruction to individuals and/or small groups of pre-school pupils who are at risk of needing special education upon entering kindergarten.

QUALIFICATIONS:

1. Physically, mentally, emotionally, and morally fit to undertake responsibilities involving the health, safety, and welfare of children. Must successfully complete a pre-employment medical examination and be free of communicable disease.
2. Holds a valid and current General Elementary or Standard Elementary credential and/or Specialist Instruction Credential in Special Education.
3. Bachelor's Degree, including all courses needed to meet appropriate credential requirements.
4. Must be able to adapt to working in spaces not normally used for group instruction when regular classroom space is not available.
5. Knowledge of current trends and research concerning growth and development of Special Education pupils, and participates in courses or workshops relevant to the above assignment at least once each year is desirable.

DUTIES:

1. Responsible for diagnosing, prescribing, implementing, and assessing pupil progress on an individual basis.
2. Assists classroom teachers in the recommendation of pupils to be tested as potential candidates for the Special Education program.
3. Provides individual and/or small group instruction to pre-school pupils.
4. Diagnoses reading problems and evaluates reading or academic area progress of pupils referred for an intensive program (not clinical diagnosis).
5. Provides a prescribed program for each pupil enrolled.
6. Constructs and develops material as needed.
7. Maintains in student's work folder short and long range goals and objectives related to district goals and objectives.
8. Establish a tentative time limit a pupil will remain in special class - reassess pupil's needs, and make recommendations to Evaluation and Placement Committee.
9. Meets with Evaluation and Placement Committee when needed or is requested.
10. Performs other duties as assigned.
