#### **ESSENTIAL JOB REQUIREMENTS - QUALIFICATIONS:**

- Support the coordination of all District Expanded Learning Programs in conjunction with site principals. Provide district-level direction to multi-site expanded learning programs, individual site-based expanded learning programs managers and community partner organizations to ensure a safe, comprehensive, collaborative service planning and programming.
- Provide instructional leadership in developing the academic curriculum for expanded learning programs in coordination with principals, expanded learning program staff, teaching staff, and the Instructional Services Division.
- Supervise and evaluate all adjunct personnel hired by the district or district partners as they provide support
- Oversee expanded learning programs during hours of operation
- Monitor delivery and quality of expanded learning program services and community providers.
- Support the Coordinator of the Expanded Learning Program with preparation for federal and state program monitoring.
- Support the establishment of a sustainable strategic plan, maximize blended funding
  opportunities and coordinate efforts to research, explore and pursue additional private
  and public funding sources to insure ongoing continuation of the programs beyond the
  termination of grant funds.

- Represent the District and expanded learning programs at interagency, regional and national meetings.
- Support project evaluation activities in collaboration with the Department of Research, Assessment & Evaluation. Participate in the review of individual and system outcomes and ongoing evaluation of program effectiveness.

- Work a flexible schedule during summer, non-instructional school days, and possibly some weekends.
