# Job Description: MENTAL HEALTH THERAPIST I



## **BASIC FUNCTION:**

Under the direction of the Coordinator-Mental Health, provide direct mental health services including mental health assessment, counseling, consultation, mental health evaluations, treatment and collateral case management for students, parents, and families; perform individual and group counseling therapy for students; serve as a resource to school site principals, service providers, students, parents and staff as assigned.

## **ESSENTIAL DUTIES:**

Provide direct mental health services including counseling, consultation, mental health evaluations, treatment, mental health assessments and collateral case management for students, parents, and families; provide clinical assessments, diagnosis and propose treatment plans for student with emotional or behaviors needs; conduct clinical interviews to gather information, determine the appropriate need, and develop diagnostic information.

Perform family therapy services to achieve student goals for treatment in a family setting; counsel family members to assist them in understanding, dealing with, and supporting students.

Lead and facilitate individual and group therapy services; teach students coping and social skills.

Act as the liaison between the Mental Health program, District staff, caseworkers, probation officers, community support services, and appropriate referrals to obtain information and coordinate services.

Serve as a resource to school site principals as assigned and discuss the treatment progress of assigned students and implementation strategies; act as a resource to teachers, parents and others in area of expertise; communicate with staff and families.

Provide crisis intervention and individual counseling for students on clinical issues such as treatment and linkage to medication evaluation, suicide and homicidal ideation, depression, impulse control; implement established treatment plans; observe and record student's behavior to assure effectiveness of plan.

Consult with school psychologist, school site administrator and staff, district administrators, teachers, paraprofessionals, and parents/guardians regarding students' mental health needs; care coordination and meeting treatment plan goals.

Prepare reports and correspondence as directed; maintains a variety of documentation, such as charting observed behaviors, clinical notes, behavior/emotional progress, treatment goals progress reports, referral forms and other data; perform any required documentation of incidents as witness to as necessary; maintain confidentiality of records relating to students.

Provide summary treatment plans at the request of clients and parents; update school staff and service providers on student progress as it is legally, ethically appropriate and in the best interest of the student as determined by the Mental Health Therapist.

Participate in meetings with the IEP (Individualized Education Plan), SST, Case Conference teams to discuss

student performance and care coordination plans.

Serve as a mandated Child Protective Services (CPS) and Adult/Elder Abuse reporter.

Assist staff in the development of behavior support plans and functional behavior analyses.

Complete paperwork to support mental health billing in a timely manner; assist with new contracts for Medi-Cal billing.

Attend and participate in meetings, conferences, seminars and professional development trainings; plan and conduct in-service mental health and behavior intervention education trainings for non-mental health trained staff.

Operate a variety of office equipment, a computer and assigned software; drive a vehicle to conduct work at various sites.

Perform related duties as assigned.

Understand, be sensitive to and respect the diverse academic, socio-economic, ethnic, religious and cultural backgrounds, disabilities of students, teachers, administrators, and staff.

Provide individual and group counseling to students and families.

Participate in the formulation, development and implementation of IEP's, related services, goals, and objectives.

Monitor and evaluate student progress.

Communicate effectively both orally and in writing.

Establish and maintain effective working relationships with staff, students, parents, service providers, outside agencies, and families.

Meet deadlines and schedules.

Maintain current knowledge of applicable laws, codes, rules and regulations.

Adapt to changing work priorities.

Communicate with diverse groups.

Set priorities.

Work with constant interruptions.

Resolve problems with tact and proficiency.

Understand, be sensitive to and respect the diverse academic, socioeconomic, ethnic, religious and cultural backgrounds, disabilities and sexual orientation of teachers, administrators and staff.

- One (1) year of experience with Medi-Cal billing and documentation.
