DESCRIPTION OF POSITION:

The Truck Driver -Stores, under the direction of the Director of Student Nutrition Services, Warehouse and Reprographics or designated employee, drives and operates motorized equipment to transport merchandise, food, supplies, mail and equipment. Performs such manual and clerical duties as necessary for receiving food, storage and distribution of food, merchandise, mail, supplies and equipment.
